1. Minutes to the November 13, 2019 meeting were approved by consensus.

3. Reports on Events – Age-Friendly 2:00PM Zoom conference with Patricia Oh Update – Bob talked with Patricia about Age-Friendly plan. The thought is that Hallowell's plan will be about eight pages. The domains of Social Participation, Respect and Social Inclusion, and Civic Participation and Employment might be addressed together. 4. Newsletter Update
Comments on first issue were positive. Time to think about the Spring Issue 2020 for months of February, March, April, May 2020. Housing – John is on the Comprehensive Plan Committee and Ordinance Rewrite Committee and can make sure that the Age-Friendly perspective is considered and included in the plan development and ordinance review process.

Respect and Social Inclusion - Maggie and Lyn

Community Support and Services – Spectrum Generations

Mike feels that we should focus attention on sidewalks, specifically those areas like North Second Street to connect the city to Augusta. Bob talked maybe about using a narrowing strategy for the west side of Greenville Street after the sidewalk runs out. Maybe some balustrades such as suggested by the Bicycle and Pedestrian Coalition and painted stripes on the side of the road could help create a safer walking space.

Mike also talked about creating low-grade exercise stations perhaps around Vaughan Field or else where in the City. He feels it is important that our plans focus on the whole city, not just downtown.

Transportation – Patrick wondered about contacting the new owners of Granite Hill and KVCAP about the opportunity for some local transportation loops into the outlying areas.

Cindy Sullivan, from the Cohen Center, couldn't be at the meeting but has a request. She is involved in a group that asked if we could gather some written stories on how lack of available transportation has affected them. If anybody has any ideas they would like to share they can contact Cindy at:
